| 6           | Committee looked at the Ottawa Valley Recreation Trail documented distributed by Mr. Patterson which was put together by County officials in conjunction with their open house town hall meetings at various locations throughout the Valley regarding their acquiring the former CP railbed from Smiths Falls to Mattawa. Mr. Patterson explained that the group are currently fact finding in local communities and dealing with questions from the public about their new 296km asset which is valued at approximately \$77 million. Mr. Patterson noted that the County has elected to call the trail the "Algonquin Trail" and it is deemed as a multi-use recreational trail. The width of the County's acquisition is expansive and County Trail officials are confident that both motorized and Non-motorized users of the trail will peacefully co-exist as each user group will have plenty of space to utilize the significant width of the trail independent of user groups which are more non-compatible. Pubic consultation will be of significance as to shaping the development of this unique corridor. |                             | open   |                 |  |

| 8    | Committee reviewed their discussion on prioritization involving Clay bank Park and Perneel area trail establishment and concurred findings indicated from their visit to both and their earlier meetings which pointed to the Perneel area being a priority zone to begin establishing working trails this fall in preparation for winter. <i>Committee Member Darcy Wall indicated that he would talk to Paul Neil, one of the adjacent land owners, on what he felt would be of assistance with this initiative.</i> Mr. Patterson stated that snowshoes will be purchased which will be available through the Healthy Kids grant and be available to public so they can utilize the trail system during the upcoming winter. It was agreed that the group would next enter the Alexander Stewart nature reserve to inventory what exist in that parcel of land and how it could be connected to the Perneel area as well as McNab Public School through established trails. <i>Mr Patterson stated he is currently gathering pricing about establishing a holding parking area at Alexander Stewart Nature reserve and should have more information about those details at the next meeting. Committee member Holly Forrest stated she would like to approach Algonquin College to see if their Forestry program would be of benefit to the Committee work as she felt they may be able to volunteer their help or give advice on trees or signage or other pertinent topics associated with trail development.</i> Committee member Darcy Wall has been researching "Food Forests" concepts and believed that educating trail users on gardening and horticultural interests would be an ideal way to feature various highlights nearby the Trail location and that it would have a natural tie-in with McNab/Braeside Market, which of course, is located at the Perneel site. <i>Darcy stated he would continue to gather more information on this concept and continue to make the Committee aware of his findings but felt adding some fruit bearing trees to help identify exactly where the trail is situated could be extreme</i> |                             | open   |                 |  |  |
