1. CALL TO ORDER AND ROLL CALL

All members of Council were in attendance this evening.

2. DISCLOSURES OF PECUNIARY INTEREST AND THE GENERAL NATURE THEREOF

No disclosures of pecuniary interest were declared at this time.

Mayor Peckett requested Council's indulgence before beginning the formal part of the Council meeting by permitting him to make a statement as follows:

Council for the Township of McNab/Braeside is committed strongly to accountability and transparency, and has exercised a number of measures since the beginning of our four-year term to enhance these two key principles of democracy. These measures include providing contact information for all members of Council on the Township website, for easy access; responding immediately to any questions, concerns, inquiries and the like, provided either to an individual Councillor or to Council as a whole; encouraging delegations and presentations at every opportunity; holding "Town Hall" meetings to enable residents to share their thoughts on topics that concern the Township; and setting up Council committees that have full community presentation from citizens and are driven by those committee members, who report back to Council. Mayor Peckett further stated that Council will continue to implement additional measures over the coming months and Council are committed to openness, transparency and engagement with the electorate. Council encourages all presentations and delegations, and are always pleased and eager to hear from the people who call this Township their home.

4. DELEGATIONS AND PRESENTATIONS

Ontrac - Kristina Lafrance-Misener, Job Developer/Employment Specialist

Ms. Lafrance-Misener was in attendance this evening to provide an overview of the services available through Ontrac, Employment Resource Centre. Ms. Lafrance-Misener advised that Ontrac provides assistance with job placement, training and workshops. Ms. Lafrance-Misener further explained that there are grants available through the Province of Ontario to cover two-thirds of the cost of a worker's training, up to \$10,000.00 and that Ontrac can assist with the completion of this application. Mayor Peckett thanked Ms. Lafrance-Misener for her presentation.

Shannon Cassidy-Rouleau - FACT-MB Inc.

Ms. Cassidy-Rouleau was in attendance this evening to request that Council consider contributing to the amount that was paid by FACT-MB Inc. for the experts that gave evidence for the defence at the recent Miller Quarry OMB hearing. Ms. Cassidy-Rouleau was clear in expressing FACT-MB Inc. feels as though the Township's lawyer, Ms. Bradley, was successful in defending the decision to refuse Miller's request for the permanent asphalt plant because of their experts and evidence brought forward (and paid for) by FACT-MB Inc. Ms. Cassidy-Rouleau respectfully requested that Council review the expenses as submitted and to consider the request from FACT-MB for reimbursement in the amount of \$95,729.93 and respond in a timely fashion. Mayor Peckett thanked Ms. Cassidy-Rouleau for her presentation and advised that a response will be provided as soon as possible, once the statements have been reviewed.

CAO/Clerk - Municipal Administration Program Certification

Mayor Peckett presented the CAO/Clerk, Lindsey Parkes, with her certificate for completing the Municipal Administration Program. Mayor Peckett further stated that The Municipal Administrative Program is comprised of four Units of study - Introduction to Local Government, Municipal Administrative Structure, Municipal Financial Management and Management in the Municipality and is administered by the Association of Municipal Clerks and Treasurers of Ontario. Ms. Parkes has also completed her Employment Law and Human Resources certification and Mayor Peckett offered his congratulations to the CAO/Clerk on behalf of Council and the Township and stated that we are very fortunate to have an employee with this type of knowledge and experience on staff.

Mandy Cannon - Executive Assistant

Mayor Peckett introduced Mandy Cannon as the new executive assistant with the Township and welcomed her to the staff.

Fire Department Service Awards

Fire Chief Dave Hartwick together with Mayor Peckett presented service awards to the firefighters. Five year service pins were presented to Mike Coulas, Nicholas Tourangeau and Chris Crowder. Dwayne Lalonde was not able to attend and will also be presented with a five year pin. Doug Kightley was presented with a 40 year ribbon from the Province of Ontario and a 40 year service pin.

Mayor Peckett thanked the Firefighters for their dedication and service and offered his appreciation for them putting their lives on the line daily and helping to make and keep the Township safe.

Moved by Deputy Mayor Armsden, seconded by Councillor Lang, THAT WHEREAS Section 286 (1) (b) of the Municipal Act, 2001 S.O. 2001 as amended states that the Treasurer is responsible for depositing all money received on behalf of the municipality in a financial institution designated by the municipality; AND WHEREAS the Township of McNab/Braeside has been approved as a new member of the Renfrew Area Administrator's Group (RAAG); AND WHEREAS the Corporation of the Township of McNab/Braeside has entered into a Consent to Addition of Customer to Interest Calculation Agreement with the other members of the RAAG and the Bank of Montreal (BMO) with respect to future Township Banking; BE IT RESOLVED that Council of the Township of McNab/Braeside appoints the Bank of Montreal as the Township's banker; AND FURTHER THAT any ONE of Mayor or Deputy Mayor TOGETHER with any ONE of CAO/Clerk or Deputy Clerk or Treasurer are authorized: 1. To sign and deliver any financial services agreements, service requests, and any other banking arrangements with BMO. 2. To give instructions, verifications and approvals on the Township's behalf from time to time. 3. Exercise power to borrow money and otherwise obtain services from BMO and to receive repayment thereof and to secure the Township's obligations to BMO arising out of the Township's acquisition of services from BMO which is conferred upon us by governing legislation. The required combination of persons are authorized to borrow money from BMO on credit from time to time in the amounts and on the terms that those persons determine and to grant security to you over any of the Township's property from time to time; AND FURTHER THAT all instructions, agreements and documents which the authorized officers sign, make, draw, accept, endorse or complete and which are signed by the persons Council has authorized from time to time are valid and binding upon the Township. The Township seal is required on any borrowing and other banking agreements, and signing officer notifications to make it valid or show consideration; AND FURTHER THAT this resolution remains in effect until cancelled by the Township by written notice to BMO and BMO has acknowledged receiving the notice.
