budget; **BE IT RESOLVED THAT** Council of the Township of McNab/Braeside approves the following amended 2015 budget and associated 2015 budget transfer to support the creation of a Township-operated McNab/Braeside Market as follows:

c) Canada 150 Community Infrastructure Program

Moved by Councillor Lang, seconded by Councillor MacKenzie, **THAT** Council of the Township of McNab/Braeside hereby authorize the application under the Canada 150 Community Infrastructure Program (CIP 150) up to \$120,000; **AND FURTHER THAT** the Township will contribute 66.67% of the total eligible project costs.

Councillor's Lang and Brum each gave examples of projects that could be funded under the Canada 150 Program. Treasurer Angela Lochtie advised that there are other grants that are better suited

to the projects mentioned by Council, as this Canada 150 grant has to be used for an expansion on something that already exists, not for new ventures or projects.

Councillor Lang briefly spoke with regards to a Canadian Heritage Grant that is available and stated that with Council's permission she will contact Canadian Heritage on the Township's behalf. CAO/Clerk Lindsey Parkes advised that staff is aware of this grant and is bringing information forward to the next regular council meeting.
