• John Kerr - Proposed Quarry Expansion - 7:00 p.m.

Mr. John Kerr thanked Council for hearing his presentation this evening and requested that it become part of the public record. Mr. Kerr reviewed the history of the land purchased by his family along Golf Club Road that runs adjacent to the Miller Quarry. Mr. Kerr further spoke to the Township rezoning of the land that is currently EMR as it was originally Rural. Mr. Kerr stated that he is in full support of the Township refusing the addition of the asphalt plant and pursuing the establishment of adequate buffers which separate the different land uses. Mr. Kerr further requested that Council rezone the land currently in question to EP in order to not permit extraction in this area. Mayor Peckett thanked Mr. Kerr for this presentation this evening

13. NOTICE OF MOTIONS

a) Ontario Energy Board - Energy East

Councillor Mark MacKenzie read the motion as follows:

WHEREAS under the *Safe Drinking Water Act 2002*, section 19, Municipal Councillors may personally be held liable in the event of a failure to protect source drinking water;

And Whereas at the same time, Municipal Councillors have no say in the acceptance or refusal of any proposed pipeline disruption remediation plan in the event of a catastrophic pipeline failure and/or leak;

And Whereas such a failure of the pipeline in or near the headwaters of the Madawaska River, the drinking water source for the Town of Arnprior, will pose a major threat to millions of people's

drinking water beyond the Town of Arnprior as the Madawaska River flows into the Ottawa River, upstream from residents living on both sides of the Ottawa River, including Canada's capital, the City of Ottawa;

And Whereas the Council of the Township of McNab/Braeside, on behalf of its residents and those living in neighbouring municipalities who will be adversely affected by a pipeline failure and/or leak, cares about the potential of said failure/leak resulting in a contamination of people's homes as well as both wells and municipal water supplies;

And Whereas the Council of the Township of McNab/Braeside is also concerned about the drastic effects a pipeline failure/leak would have on people's livelihoods, given that both the Madawaska and Ottawa rivers drive a billion-dollar boating, recreational and tourism industry;

Therefore Be It Resolved That the Council of the Township of McNab/Braeside supports Councillor Mark MacKenzie and Councillor Heather Lang to seek intervener status on the Township's behalf at the National Energy Board hearings relating to the Energy East project, and similar status to speak at an upcoming hearing of the Ontario Energy Board, to share these concerns;

And Be It Further Resolved That a copy of this resolution be forwarded to Prime Minister Stephen Harper; Thomas Mulcair, Leader of the Federal NDP; Justin Trudeau, Leader of the Federal Liberals; Elizabeth May, Leader of the Green Party of Canada; Cheryl Gallant, MP for Renfrew County; John Yakabuski, MPP for Renfrew County; Premier Kathleen Wynne, Andrea Horwath, Leader of the Ontario NDP; Tim Hudak, Leader of the Ontario Conservatives; TransCanada Pipeline; and the Ontario Energy Board; as well as to the Councils of the Town of Arnprior, Town of Renfrew, Township of Horton, City of Ottawa.

Mayor Peckett requested that this resolution be brought forward to the January 20, 2015 regular meeting of Council for consideration of passing.

- a) Jeff Burns Mr. Burns stated that he does not feel that the buffer of 300 meters from the extractive zone is enough and would like to see it increased to 400 metres as recommended by the previous Council on June 11, 2013.
- b) David F Simek Mr. Simek stated that he agreed with Mr. Burns and felt the setback to the quarry land should be larger than proposed.

Council recessed for 5 minutes at 7:35 p.m.
