Moved by Councillor Lang, seconded by Mayor Peckett, **THAT WHEREAS** the Alexander Stewart Provincial Nature Reserve is part of the Ontario Government's Living Legacy Land Use Strategy; **AND WHEREAS** the Alexander Stewart Nature Reserve is a 30 hectare area located in the Township of McNab/Braeside; **AND WHEREAS** the site was donated by a landowner in 1966 for protection in pubic ownership and formally established as a Provincial Park in July 2003 by Ontario regulation 238/03; **AND WHEREAS** the Province has stated that these lands are protected and activities that

have been traditionally enjoyed in the areas will continue provided that these uses do not impact on the natural features needing protection; and further that hunting and commercial trapping are not permitted, **THEREFORE BE IT RESOLVED THAT** Council of the Township of McNab/Braeside requests that the Province of Ontario pick up where they left off many years ago to make this space usable to the public and undertake a management planning process to determine the long-term management of this protected area and further request that the Ministry of Natural Resources place the signage to recognize the private donors of this site.
