b) White Lake Rink Boards

Moved by Deputy Mayor Armsden, seconded by Councillor Brum, THAT WHEREAS the Township of McNab/Braeside's application to the Hydro One's PowerPlay Grant Program for Rink Board Upgrades at White Lake Park has been approved in the amount of \$10,000; AND WHEREAS the cost of new rink boards was previously estimated to be \$50,000 plus HST, however, a formal sealed tender process has not yet been initiated by staff; AND WHEREAS the Township has already set aside \$24,000 in the Capital Asset Replacement Reserve-Recreation-Equipment and Vehicles for this capital project; AND WHEREAS Purchasing By-Law 2014-51 section 4.2.1 states that unspecified capital expenditures require prior Council approval by resolution; AND WHEREAS Purchasing By-Law 2014-51 section 5.3.2 states that if the preferred quotation exceeds the total project budget by 10%, the Department Head shall submit a report to Council for direction; AND WHEREAS, considering this 10% rule, the maximum acceptable spending level for this project before being required to return to Council is approximately \$56,000., THEREFORE BE IT RESOLVED **THAT** the Council of the Township of McNab/Braeside hereby approves the capital expenditure of Rink Board Upgrades at White Lake Park at an estimated cost of \$50,000 plus HST; AND FURTHER THAT Township funding for the upgrade be derived from a transfer of up to \$46,000 from the Capital Asset Replacement Reserve-Recreation-Equipment and Vehicles.

Moved by Deputy Mayor Armsden, seconded by Councillor Brum, **THAT WHEREAS** the Township of McNab/Braeside is due to complete its five year review of the Official Plan as required under the Planning Act to ensure it is consistent with Provincial Policy Statements; **AND WHEREAS** the County of Renfrew is undergoing a comprehensive review of its Official Plan; **AND WHEREAS** 10 of the local Municipalities utilize this upper tier plan as their Official Plan; **AND WHEREAS** Council of the Township of McNab/Braeside has reviewed the benefits of utilizing the County Official Plan for their own use; **THEREFORE BE IT RESOLVED THAT** Council deems it in the best interest of the Township to work with the County to include the Township in the County of Renfrew Official Plan Process.

CARRIED.

Council directed staff to send a copy of the above resolution to Charles Cheesman and Paul Moreau at the County of Renfrew.

c) Energy East Pipeline Project - Update

Councillor Lang advised of the report that became available by the Ontario Energy Board on August 13, 2015. She will forward the link for the report to Council.
