#### 4. **DELEGATIONS AND PRESENTATIONS**

Andrea & Johann Reichart - Renewable BioMass Project

Mr. Reichart was in attendance this evening as requested by the Planning Advisory Committee to present information and clarification with regards to his Renewable BioMass project proposed for his property at 434 Goshen Road and request that Council endorse the FIT Contract resolution for this project.

WHEREAS capitalized terms not defined herein have the meanings ascribed to them in the FIT Rules, Version 4.0., Johann Reichart (the "Applicant") proposes to construct and operate a Renewable BioMass (the "Project") on 434 Goshen Road, Braeside, Ontario (the "Lands") in McNab/Braeside under the Province's FIT Program; AND WHEREAS the Applicant has requested that Council of the Municipality of McNab/Braeside indicate by resolution Council's support for the construction and operation of the Project on the Property; AND WHEREAS pursuant to the FIT Rules, Version 4.0, Applications whose Projects receive the formal support of Local Municipalities will be awarded Priority Points, which may result in the Applicant being offered a FIT contract prior to other Persons applying for FIT Contracts; NOW THEREFORE BE IT RESOLVED THAT Council of the Municipality of McNab/Braeside supports the construction and operation of the Project on the Lands. This resolution's sole purpose is to enable the Applicant to receive Priority Points under the FIT Program and may not be used for the purpose of any other form of municipal approval in relation to the Application or Project or any other purpose.

Moved by Councillor MacKenzie, seconded by Councillor Lang, **THAT** Council endorse a site specific Municipal Support Resolution as submitted by Johann Reichart for a Renewable BioMass Project located at 434 Goshen Road, Braeside, Ontario in the Township of McNab/Braeside.

Representatives from TransCanada Pipeline were in attendance at Council's request and presented some new information to Council including some changes to where pumping stations will be located, specifically a pumping station that was going to be in Horton Township, but will now be in the Township of McNab/Braeside. TransCanada is still looking into a number of determining factors but there are a few sites within the Township that they are considering.
