6. **ITEMS OF BUSINESS**

Fee By-Law

The Draft Fee by-law was reviewed with the possible changes as previously recommended by Council and Staff. The CAO/Clerk was requested to bring back further information regarding an

adjusted by-law enforcement rate should the launch fees and parking fees at the beaches and boat launches be revised. The Fee for ownership change is to be removed, this will have an \$2,500.00 budget impact. Further information was also requested as to requirements for running the canteen through the Township. Council discussed the possible allocation of the revenue received from the sale of dog tags, this matter will be discussed further after the budget.

Overview of 2015 Budget

The Treasurer presented Council with an overview of the draft 2015 Budget provided (attached to the minutes as Appendix A). The Budget presentation was based on Department Head Submissions. The Treasurer advised as background information that a 1% levy increase is equal to a \$37,076 cost increase, and that a 1% tax rate increase is equal to \$39,617.00 in tax revenues. The average assessment for a single family detached dwelling not on water is \$243,586.00. There are 2174 properties of this type in the Township.
