1. CALL TO ORDER AND ROLL CALL

All members of Council were in attendance this evening.

2. DISCLOSURES OF PECUNIARY INTEREST AND THE GENERAL NATURE THEREOF

No disclosures of pecuniary interest were declared at this time.

4. DELEGATIONS AND PRESENTATIONS

• Laura Tromp - Physician Recruitment Funding - 7:00 p.m.

Ms. Laura Tromp, Physician Recruitment Co-Ordinator for Arnprior Regional Health was present this evening to address Council and submit a request for support for the Family Physician Recruitment program. Ms. Tromp gave Council an overview of the committee's accomplishments in 2014 and advised of the current status with regards to the two new physicians currently accepting patients at the hospital. The goal of the Physician Recruitment Committee is to attract

1 family physician in 2015 and 2 in 2016, however, the committee is looking at a husband and wife who are "locum" prospects. In closing, Ms. Tromp advised that, they are requesting \$25,000.00 from McNab/Braeside Township and the same amount from the Town of Arnprior. Mayor Peckett thanked Ms. Tromp for her attendance and presentation this evening on such an important issue and advised that Council would consider this request for financial support and advise accordingly.

• Stantec Consulting Ltd. - Property Condition Assessments 7:15 p.m.

Mr. Detlev Grad from Stantec Consulting Ltd was in attendance this evening to give Council an overview of the Property Condition Assessments completed earlier in the fall. Mr. Grad advised that visual inspections of the building were done and submitted the scope for the work for 14 of the 22 buildings in the Township's ownership and the priority of any work and/or maintenance that is required. Moved by Councillor Brum, seconded by Councillor Lang, **THAT WHEREAS** Canada Post has proposed a plan to end residential home delivery in Canada; **AND WHEREAS** the lack of home delivery will disadvantage many senior and people with mobility problems and will be compounded during inclement weather; **THEREFORE BE IT RESOLVED THAT** the Township of McNab/Braeside does not support the proposed plan to eliminate residential home to home delivery and herein petition Canada Post to reconsider this plan immediately and retain this valuable service for communities; **AND FURTHER THAT** a copy of this resolution be forwarded to the Association of Municipalities of Ontario, Federation of Canadian Municipalities, Municipalities in Ontario, as well as to our local MP, MPP and representatives of Canada Post and its unions to encourage others to speak up against this plan.
