• TransCanada, Energy East Pipeline Project

Ms. Nathalie Guay, TransCanada, Energy East Pipeline Project, Mr. Alaine Parise, Director of Aboriginal Relations, Canada East Tribal Relations and Land, and Mr. Jon Pitcher, Community Relations Lead - Ontario of TransCanada were in attendance this evening to provide Council with a brief history of the TransCanada Energy East Project. Mr. Parise explained that the proposed 4,400 km project will carry 500,000 to 850,000 barrels per day of crude oil from Alberta and Saskatchewan to refineries in Eastern Canada. This will replace imported oversea products with a Canadian product. This project will include the conversion of 3,000 km of existing natural gas pipeline in Saskatchewan, Manitoba and Ontario into an oil pipeline. It will also include the construction of new facilities, pump stations and tank terminals. TransCanada will be engaging with local communities throughout the project and meetings with landowners, Council and aboriginal groups. Mayor Campbell thanked Mr. Alaine Parise and Ms. Nathalie Guay for their very informative presentation this evening.
