Ms. Hoddinott was in attendance this evening and presented the Committee with the history of the property known as Clay Bank Park, including how it was acquired and the Township's intention at the time of purchase. Ms. Hoddinott also advised that 745 signatures have been obtained on a petition (245 from the Township) arguing against the development of the Park into an RV Park. Ms. Hoddinott had several questions with regards to the RV proposal and if the Township has done its due diligence. Chair Armsden advised the Council is currently doing its due diligence and will not move forward with any proposals until they are satisfied that they have all of the information they require.

#### Evans McNab - Road Allowance

Committee Member Tom Peckett explained that Mr. McNab owns property, however he has no access except across a Township road allowance to brush and cut trees. Mr. McNab stated that he also wishes to purchase the road allowances that abut his properties along with the part of the road allowance that will give him access from Usborne Street. Mr. McNab was advised that the Committee will review the additional information and render a decision at the April 21<sup>st</sup> regular meeting of Council barring any unforseen matters.
