7.1 TENDER OPENING SUMMARY & DISCUSSION

Mr. Frew explained that the purpose of this meeting is to discuss the Tender Opening and determine next steps. There were nine bids received, these bids still have to be reviewed to confirm compliance. Based on the base price (as read), the estimates all came in over the estimated budget. The tenders that were submitted were not broken down by building or site work thereby making it difficult to determine where the tendered costs varied from the budget estimate. Jacob Kelly advised that a possible next step is to do a post-tender addendum to the lowest bidder before awarding the contract, asking for a specific break down of costs, which could be used to negotiate specific scope changes.

Ms. Lochtie confirmed that by taking the lowest bid amount into consideration would push the debt repayment into the medium-high range.

The Building Committee agreed that the next steps are for +VG Architects to analyze the bids and determine who the lowest (and conforming) bidder is when the installation of the emergency generator and geothermal system is taken into consideration. Once this has been determined, a post-tender addendum will be sent to this bidder requesting a detailed breakdown of the bid. Once the results of this breakdown have been received, the Building Committee will make a recommendation to Council for consideration.
