7. Items of Business

7.1 Update on Flooding

Greg Lough, CEMC, updated Council on the 2017 Flood Event as follows:

As of Monday evening at 5:00 p.m. there are 23,000 sand bags in place or filled and prepositioned, 3,000 sand bags in reserve (from MNRF), and 6,000 sand bags arrived Monday to augment our cache.

There have been approximately 40 primary/permanent homes affected, 42 seasonal homes and 1 small business.

25 people remain in place within an impacted area. The McNab/Braeside Fire Department continues to support those individuals by conducting wellness checks, assisting with maintenance of the flood control structures and pumps and providing drinking water.

Priority remains health and safety of those within the impacted areas. Regular wellness checks and supply of drinking water are being carried out.

Sanitation - Garbage removal for those within flood zone. Drinking water (wells) and septic issues - well and drinking water safety information is being pushed on Social Media and Township website.

Looking forward - We will be entering the Recovery Phase. Planning is needed to ensure smooth transition. Monitor sanitation and push info on personal hygiene until water recedes and debris management plan is in place.

Chief Hartwick provided Council with a verbal update of the Fire Department's involvement in the sand bagging, flooding and road closure issues that were encountered from May 1, 2017 to date. Chief Hartwick advised that the homeowners were monitored and discussions were on-going with the CAO and CEMC for direction and given updates as required. Bottles for water testing and submersible pumps were dropped off to affected residents where required. Garbage

was collected from houses where there was no access by road. Chief Hartwick concluded by advising Council that all operations were on-going at this time and will be monitored throughout the next few weeks.
