5.1 Committee Member Mark MacKenzie stated that he has done some research and learned a lot about group homes and the definitions of a resident. Procedurally he felt there were some issues with the proposed By-Law and the definitions. Committee Member Mark MacKenzie read the definitions of group home as outlined in the Township's Zoning By-Law and the Municipal Act and the definition of living. The Justice Department and Statistics Canada both have definitions of living and there is nothing in the Planning Act. Human Rights is not an issue as this is not their normal place of residence. Committee Member Mark MacKenzie stated he is in favour of the business being successful, but also agrees with the comments made by the area residents, and that the vagueness of the By-Law definition leaves room for unscrupulous persons to come in.
