## Notice is hereby given to the Municipal Electors of the Corporation of the Township of McNab/Braeside

Candidates for the following offices may file nomination papers at the office of the Clerk, 2508 Russett Drive, Arnprior, ON K7S 3G8, beginning <a href="May 1, 2018">May 1, 2018</a> and no later than 2:00 p.m. on Nomination Day, Friday, July 27, 2018.

#### **School Board Trustee Elections:**

#### **Trustee, Renfrew County District School Board**

- One (1) to be elected for the combined area of the Town of Arnprior and the Township of McNab/Braeside.
  - \*Nomination Papers to be filed with the Clerk of the Town of Arnprior

#### Trustee, Renfrew County Catholic District School Board

- One (1) be elected for the combined area of the Town of Arnprior, the Township of McNab/Braeside and Greater Madawaska
  - \*Nomination Papers to be filed with the Clerk of the Town of Arnprior

#### Conseiller (ère), Conseil des écoles publiques de l'Est de l'Ontario

- One (1) elected for Area 1 which includes Lanark and Renfrew Counties and the Township of South Algonquin
  - \*Nomination papers to be filed with the Clerk of the Town of Petawawa

### Conseiller (ère), Conseil des écoles catholiques du Centre-Est

- One (1) elected for Area 3 which includes Renfrew County and Township of South Algonquin
  - \*Nomination Papers to be filed with the Clerk of the Town of Petawawa

Nominations may be made by completing and filing the prescribed form in the office of the Clerk, and accompanied by the prescribed filing fee, of \$200.00 for the Head of Council and \$100.00 for all other offices. The filing fee is payable by cash, certified cheque, money order, or debit.

A nomination must be signed by the candidate and may be filed in person or by an agent during regular business hours between May 1, 2018 and July 26, 2018, and between 9:00 a.m. and 2:00 p.m. on July 27, 2018 (Nomination Day).

In the event there are insufficient number of certified candidates to fill all positions available, nominations will be reopened for the vacant positions only on Wednesday, August 1, 2018, between the hours of 9 am and 2 pm and such additional nominations, if required may be filed in the office of the Clerk.

Electors are hereby given notice that if a greater number of candidates are certified than are required to fill the said offices, eligible voters may cast their vote during the voting period of Tuesday, October 9<sup>th</sup>, 2018 at 9:00 a.m. to Monday, October 22, 2018 at 8:00 p.m. either via internet or telephone.
