	<ul> <li>Have a piper (e.g., Bobby Smith) pipe the baton carrier from the boat launch to the stage, accompanied by Mr and Mrs McNab (dressed as the Laird and his wife) or have the descendants of the Laird of McNab participate in this final leg (suggestion made by Georgia Quinn).</li> </ul>				
	Have the Celtic Society provide items for the time capsules.				
	<ul> <li>Members of the Orange Lodge (who wish to be involved) will operate some of the refreshment stations.</li> </ul>				
	ACTION: Relay Captains will indicate where watering stations should be located.
