The deadline for pick-up is June 30<sup>th</sup>, 2019, but is subject to change based on water levels.

i. A certified copy of the Firm's Public Liability and Property Damage Insurance Policy for the works coverage in respect of any one accident to the limit of at least \$2,000,000.00 per accident in the name of the Municipality.


- ii. Automobile liability insurance in respect of licensed vehicle shall have limits of not less than \$2,000,000.00 inclusive per occurrence for bodily injury, death and damage to property, in the following forms:
  - standard non-owned automobile policy including standard contractual liability endorsement, and
  - standard owner's form automobile policy providing third party liability and accident benefits insurance and covering licensed vehicles owned or operated by the Contractor.
- ii. A valid Workplace Safety Insurance Board Certificate of Clearance at the time of commencement.
- iii. Statement of work and worker safety procedures to be implemented to fulfill the requirements of the Health and Safety Act.

**Note:** Any damage to private property and/or roadways caused by work carried out under this contract will be the responsibility of the Contractor.


**Note:** If an extension to the deadline is required, a request must be submitted to the Township, in writing, no later than one week prior to the required completion date.


## TOWNSHIP OF MCNAB/BRAESIDE MAP 1
