WHEREAS Council passed a Deeming By-law that deregistered Plan of Subdivision Number 512, located in Part of Lots 9 and 10, Concession 6, Geographic Township of McNab, now in the Township of McNab/Braeside; AND WHEREAS the requirements of the subdivision agreement regarding the construction Hidden River Road and Gunsmith Road have not been completed; AND WHEREAS the Township has concerns regarding the impact of potential new residential dwellings being constructed on the former subdivision lands on a road not up to Township standards; AND WHEREAS for the purposes of addressing these concerns before further development proceeds, Council has determined that it is in the best interests of the Township that it undertake a review and/or study of the land use planning provisions which currently allow residential uses on the subdivision lands; AND WHEREAS the purpose of the review and/or study will determine the appropriateness of the land uses and to make recommendations to Council about whether amendments to the Zoning By-law should be made in the best interests of the Township;

NOW THEREFORE BE IT RESOLVED THAT:

1. The Township hereby directs its land use planner to review and/or study land use planning provisions related to the use of lands located within Plan of Subdivision 512, located in Part of Lots 9 and 10, Concession 6, Geographic Township of McNab, now in

the Township of McNab/Braeside, and consider appropriate zoning standards.

- 2. The purpose of the review and/or study shall be to determine if the existing road is appropriate for new development. The review and/or study will also analyze the status of the subdivision lots in terms of, the goals and directives of the Provincial Policy Statement, the Township's Official Plan, the intended development of land, and to make recommendations to Council as to whether amendments to the Zoning Bylaw are required.
- 3. The Township Planner is directed to undertake the planning study and to complete the planning review and study as soon as possible.
