### **RESOLUTION - 510-2016**

Moved by Deputy Mayor Armsden, seconded by Councillor Lang

**WHEREAS** Plan 512 has been registered for more than 8 years and requirements of the subdivision agreement have not been met including: construction of roads, drainage easements, provision of securities, and parkland dedication;

**AND WHEREAS** on January 19, 2016 the Municipality adopted By-law 2016-09 which deemed the subject lands (Plan 512) under Section 50(4) not to be a Registered Plan of Subdivision for the purposes of Subsection 3 of Section 50 of the Planning Act, R.S.O., 1990, c.P. 13;

**AND WHEREAS** on January 19, 2016 the Municipality adopted By-law 2016-10 being an Interim Control By-law (ICBL) to restrict new dwellings from being constructed in the subdivision for a period of one year. The ICBL was necessary to stop a problem

from getting out of hand, and to provide breathing space during which a study could be done to determine the appropriate planning controls for dealing with the situation;

AND WHEREAS a planning study was completed that recommended a holding symbol;

AND WHEREAS By-law 2016-10 (ICBL) would expire on January 19, 2017;

**AND WHEREAS** on October 18, 2016 the Township passed By-law 2016-56 which imposed a holding zone on the lands (former Subdivision Plan 512) which is not to be lifted until conditions have been satisfied to the Township's satisfaction;

**AND WHEREAS** there was an appeal to By-law 2016-56 for the following reasons: it is excessive and unnecessary; and it is vague and uncertain;

**NOW THEREFORE BE IT RESOLVED THAT** the Council of the Corporation of the Township of McNab/Braeside supports By-law 2016-56 as adopted by Council for the following reasons:

- i) A holding zone is common and frequently used by the Township of McNab/Braeside and other Municipalities in Ontario to control the future development of lands;
- ii) The holding zone was implemented in accordance with the requirements of the Planning Act;
- iii) The holding zone is required for the protection and safety of existing and future residents;
- iv) The holding zone is required for the orderly development of the lands;
- v) The holding zone conforms to the policies of the Township of McNab/Braeside Official Plan.
