7. **DELEGATIONS AND PRESENTATIONS**

JP2G – Lot Development Fees

Mr. Whitehead introduced Mr. Withers and explained when and why Lot Development fees were introduced. In 1997 rules were developed to provide consistency over all Municipalities with regards to Lot Development Fees.

Mr. Whitehead and Mr. Withers reviewed all the tables provided to Council and Council reviewed line by line. Mayor Campbell asked all members how they wished to proceed, the majority of Council wished to move forward with the current recommendations.

The following changes were recommended:

General Eligible Services – Add Official Plan Review in 2015 at a cost of \$37,000.00

Transportation - Remove Sand Shed Braeside and Rubber Tire Excavator

Recreation – Remove: Dochart Storage Building; Zamboni; Wellington Park Splash pad; Perneel Building; Red Pine Bay Park; ½ Ton Truck with trailer; and side by side (Red Pine Bay). Change: description to Wellington Park Development (remove Ice Rink specification) and change amount to \$100,000.00; change description to McNab Centre Park Development (remove batting cage and/or tennis court specification) and change amount to \$50,000.00; change description to Braeside Beach Development (remove trail to red pine bay specification); increase amount of Clay Bank Park Development to \$200,000.00; and change description of Recreation Master Plan to Recreation Strategic Plan. Add White Lake Community Centre with a cost of \$500,000.00 and an estimated expenditure year in the 5-10 year bracket.

Staff Direction – Council requested that the Deputy Clerk obtain a cost for a proposal from Stantec to do a general study for upper Dochart watershed from the highway to the landfill for a special area development charge.
