5	Recreation Director Patterson circulated Recreation Committee meeting minutes from May which were approved, moved by Committee member Teresa Bahm, seconded by chair Marshall. Carried.		closed	17/6/7

7	Correspondence included the Director's email update on programs/facilities highlighting a very busy season which is well underway. Field prep was still a priority with daily ball and soccer field bookings almost totally at 100% full for season. Final archery program session held at RA Centre with positive feedback received. Some delays getting Parkland fully operational due to storm clean-up but Rec areas expected to be fully operational shortly. Numbers up in horseshoes at Wellington, EOSSA tourney at Dochart successful and special event preparation progressing nicely. No questions arose as a result of the Director's status report. The group had the opportunity to digest the participant numbers forwarded by Renfrew Recreation and weighed in on their interpretation of those numbers. It was felt we were on	GР	open	17/6/7

It was also noted that our Township had the lowest percentage of the users of all Renfrew's neighbouring Townships. (12% of all their out-of-town users were from M/B)			
8	Committee focused on a request by Skiability group for the use of the Rowing Club area at Burnstown Beach for the purposes of holding an event on August 13. The Committee had dealt with this request before and have a long relationship with this charitable group that provides opportunities for special populations to enjoy a day of water skiing and other water-based activities. Moved by Jason Marshall, seconded by Teresa Bahm that Council allow the Skiability group to use the Rowing Club portion of Burnstown Beach at no charge for the purposes of executing a special event on August 13. Carried. ANOTHER special event that the group considered was a proposal for a cycling event by long-time volunteer Andy Kalnins. Moved by Matt Arseneau, seconded by Jason Marshall that Council approve a partnership between the Recreation Department and Andy Kalnins and Tim Lewis for the purposes of executing an Eco Cycle tour on the McNab/Braeside Recrational trail during the summer/fall months. Carried. Programs were again discussed which could be held at the new Perneel area during this month's visioning exercise. Chair Marshall, added ideas to a list supplied by Ms Belton, the	GP	open

Committee reviewed a potential contract and guidelines that the contractor would be asked to meet and the revenue generated by this proposal to the Township would be \$1000 for the season. Moved by Matthew Arsenau, seconded by Jason Marshall that Council approve establishment of a contract between the Township and Gordon MacDowell for the purposes of operating the Beach canteen at Burnstown for the summer of 2017 providing a proper contract is signed and secured as reviewed by the CAO.
