4.	Committee heard from Councillor Mark Mackenzie who was in attendance as a delegation this evening. Councillor Mackenzie spoke of a casual drop-in ball hockey program he had initiated at White Lake with some assistance from volunteer Monique Keenleyside. Mr. Mackenzie inquired as to whether the programmer could answer inquiries relating to the ball hockey open house and develop a flyer. He asked about equipment available to support this program and elaborated on how their first attempt at the program went and felt that regular hours be established Saturday mornings from 9:30-11:30am. Councillor Mackenzie asked if the surface was due to be painted and if the ball hockey group could provide assistance with that task at a Saturday after the program ended. Rec Programmer Karla Belton briefly presented a verbal recap of past events and what is planned for the future. The itinerary was busy as she spoke of an established after-school program, a very successful Movie night at McNab Public School and future events such as a continuation of the after school program, a subsequent movie night October 13, a Braeside rinkboard fundraiser on the 20 <sup>th</sup> of October. The Director added a few words on ball tournaments, past cycling and rowing events that took place in September, then spoke of upcoming events such as White Lake Fallfest October 28 <sup>th</sup> , the Tuff Tartan Trek Nov 25th and planning for fall/winter programming such as star gazing and snowshoeing.
