9. Questions/Comments

- 9.1 Residents asked how they could protect themselves and were looking for further clarification on how and why this flood happened. They expressed their frustration over the lack of information provided in the report.
- 9.2 Residents asked if the flood would happen again and if they should prepare. They were advised that no one now can say for sure if or when another flood will occur but that residents should be prepared.
- 9.3 There was some discussion on the dams and whether or not they played a role in the flooding.
- 9.4 Residents inquired as to when Archibald Street would be repaired. Mayor Peckett explained that the Township had applied for funding from the Province to assist with expenses occurred by the Township during the flood. The road will be repaired once we are in receipt of those funds.

- 9.5 Residents suggested that a permanent wall or higher road should be built by the Township.
- 9.6 When asked if the Military could come sooner and help prepare, Mayor Peckett advised that the Military responded as quickly as they could and can only respond (among other criteria) if the Township is in a state of emergency.
- 9.7 Mayor Peckett expressed the importance of residents preparing themselves and advised that the Township will assist when possible.
