7.3 Transition to Full Producer Responsibility - Blue Box Program

RESOLUTION - 180-2020

Moved by Deputy Mayor Brian Armsden, seconded by Councillor Oliver Jacob **WHEREAS** the amount of single-use plastics leaking into our lakes, rivers, waterways is a growing area of public concern;

AND WHEREAS reducing the waste we generate and reincorporating valuable resources from our waste stream into new goods can reduce GHGs significantly;

AND WHEREAS the transition to full producer responsibility for packaging, paper and paper products is critical to reducing waste, improving recycling and driving better economic and environmental outcomes;

AND WHEREAS the move to a circular economy is a global movement, and that the transition of Blue Box programs would go a long way toward this outcome;

AND WHEREAS the Corporation of the Township of McNab/Braeside is supportive of a timely, seamless and successful transition of Blue Box programs to full financial and operational responsibility by producers of packaging, paper and paper products;

AND WHEREAS the Association of Municipalities of Ontario has requested municipal governments with Blue Box programs to provide an indication of the best date to transition our Blue Box program to full producer responsibility;

AND WHEREAS the Corporation of the Township of McNab/Braeside is concerned about a recent proposal by the Ministry of Environment, Conservation and Parks that could jeopardize over 135 small rural, remote, and Northern community Blue Box programs across the Province as well as servicing to schools and public spaces;

THEREFORE BE IT RESOLVED THAT the Corporation of the Township of McNab/Braeside would like to transition their Blue Box program to full producer responsibility on July 29, 2023;

AND FURTHER THAT this decision is based on the following rationale:

- 1. The Township's Blue Box Collection and Processing Contracts expire on July 28, 2023 along with our neighbouring municipalities of the Town of Arnprior and Town of Renfrew in which we jointly tendered for these services;
- 2. Transition can occur concurrently with neighbouring municipalities which will allow producers to consolidate promotion and education programs, reduce costs and better inform our residents;

AND FURTHER THAT the Corporation of the Township of McNab/Braeside would not be interested in providing collection services to Producers;

AND FURTHER THAT the Corporation of the Township of McNab/Braeside strongly advocates for language to be included in the regulation that ensures municipalities under 5,000 continue to receive Blue Box servicing as was agreed as part of the Provincial government's Blue Box mediation as well as schools and public spaces;

AND FURTHER THAT the resolution be forwarded to the Association of Municipalities of Ontario and the Ontario Ministry of the Environment, Conservation and Parks.

7.4 Blue Box Recycling - Collection and Processing

RESOLUTION - 181-2020

Moved by Councillor Oliver Jacob, seconded by Councillor Heather Lang **THAT** Council award the contract for Recyclable Material Collection Services to Topps Environmental Solutions (803836 Ontario Inc.), Carleton Place, Ontario for the first year price of \$206,567.71 plus HST for OPTION 2 Transportation of materials to the Emterra Environmental's MRF in Renfrew; **AND THAT** the term of the contract shall be from August 3, 2020 to July 28, 2023; **AND THAT** the Township shall have the right to extend the contract for one (1) year for up to two (2) extensions; **AND THAT** the price of each subsequent year of the contract be adjusted based on stop count, CPI and pricing allowances for fuel costs; **AND THAT** the annual cost is subject to a discounted rate upon satisfying conditions of group procurement **AND THAT** Council authorizes the Mayor and CAO/Clerk to sign the agreement on behalf of the Township;

AND FURTHER THAT Council authorizes the Mayor and CAO/Clerk to formalize an agreement with Emterra Environmental (Halton Recycling Ltd.) for processing and marketing of Blue Box Recyclable materials.
