7.1 2020 Draft Budget Presentation - Day 1

Treasurer Coughlin advised that there were some line items in this evening's budget that are inaccurate. These discrepancies include:

Page 17 - The Request of \$5,000 from CPAC has been withdrawn (CPAC was actually meant to say CSWB (Community Safety Well Being Planning).

Page 32 - The decrease in salaries/wages/benefits for the Environmental Services Department requires further investigation.

Page 34 - The line painting was completed in 2019, however the invoice was not received at the time of the budget. It has now been received and an additional \$6,000.00 has been requested for the 2020 budget, for a total of \$23,000.00.

Page 35 - "White Lake Road" should read "White Lake Roads"
