# 7.1 2021 Cut/Keep Budget Deliberations

The starting point for this evening's budget after implementing cuts discussed at the previous budget discussions is an 8.87% levy increase.

Council reviewed the cut/keep list. The following changes were made in Round 1:

Cut: "Additional 0.5% increase in wages - All Staff excluding Council".

Cut: "Additional 0.5% increase in wages - All of Council and C of A members - excluding Mayor increases in base wage".

Cut: "Introduction of Vision Care Improvement".

Cut: "Summer Student Supervisor" (Parks & Recreation).

Chief Hartwick vacated the Council Chambers at this time (7:10 p.m.).

Amend: "Wellington Park - Misc. Supplies" - change 2 horse shoe pits, to 5.

Cut: "Council Misc. - Strategic Plan".

Mayor Peckett vacated his chair at 7:23 p.m. stating pecuniary interest, the disclosure and reason thereof was stated by Mayor Peckett because item 7.1, Line Item "Council-Salaries & Wages - Increase Mayor Base Salary" directly benefits him.

Mayor Peckett returned to his chair at 7:24 p.m.

Cut: "Council - Salaries & Wages - Increase Mayor's Base Salary".

# Council recessed at 7:24 p.m. The Council meeting resumed at 7:28 p.m.

Add: CBO SUV - \$35,000 (the purchase of this vehicle does not impact taxation).

Cut: "(2) Mobi-Mats - Burnstown Beach".

Reduce the reserve transfer percentage to 3% for everything but paved roads on page 9.

Council recessed at 8:46 p.m. The Council Meeting resumed at 8:50 p.m.

After the first round of cut/keep, the proposed tax levy increase is 5.90%.

Council recessed at 8:53 p.m. The Council resumed at 8:57 p.m.

Treasurer Coughlin explained that although the approximate impact on the levy increase is currently at 5.90%, it would not increase the tax rate for residents. They would see no change or a small decrease on their tax bill.

With this information, Council reviewed the cut/keep list for a second time, the following additional changes were made in Round 2:

Add: "Additional 0.5% increase in wages - All Staff excluding Council" back into the budget.

Cut: "Introduction of a \$500 Health Care Spending Account".

Cut: "New PW Summer Student".

Cut: "Museum Advertising".

Mayor Peckett vacated his chair at 9:58 p.m. stating pecuniary interest, the disclosure and reason thereof was stated by Mayor Peckett because item 7.1, Line Item "Council-Salaries & Wages - Increase Mayor Base Salary" directly benefits him.

Mayor Peckett returned to his chair at 10:03 p.m.
