1. Call to Order and Roll Call

2. Disclosure of Pecuniary Interest and the General Nature Thereof

3. Adoption of the Agenda

7. Items of Business

7.1 Proposed 2020 Operating Budget

The starting point for this evening's budget was a 9.07% levy increase.

Council reviewed the cut/keep list. The following changes were made in Round 1:

Operating Budget

Introduction of a 50% increase to H&D, Life/ADD premiums - Ms. Coughlin provided that the tax funded amount for this line item would be \$10,552 and a 0.19% levy increase.

Culvert/Catch Basin Maintenance - Cut to \$2,500

Sweeping/Cleaning - Cut to \$2,000

Clay Bank Park - Add \$3,000

Murray Yantha Community Centre - Equipment Rental Winter Mats - Cut \$2,000

2010 GMC Red 3/4 Ton Truck - Cut to \$250

Red Tractor - Cut to \$750

2013 White Ram 1500 Pickup - Cut to \$750

ATV - Cut to \$750

Minor Ball - Uniforms - Take \$2,100 from reserves as opposed to adding it as a levy increase

Programs & Special Events - Add \$2,417

Waba Cottage Museum & Gardens - Add \$3,600

Planning & Zoning - Professional Fees - Cut \$8,000

Council recessed at this time 7:05 p.m.

Council resumed at 7:21 p.m.

Postage - Cut \$1,500 Courses and Training – Keep \$3,486, Cut \$2,500 (Report Writing) Strategic Plan Update - Cut \$5,000

Council wished to discuss the following items further before making a decision: Introduction of a \$500 Health Care Spending Account Membership Dues (StreetScan)
Library Agreement - Arnprior (Community/Resource Librarian)

Council recessed at 7:53 p.m. Council resumed at 7:57 p.m.

Capital Budget:

There were no changes made to the proposed Capital Budget at this time.

After the first round of cut/keep, the proposed tax levy increase was 8.73%.

Council reviewed the cut/keep list for the proposed Operating Budget for a second time, the following additional changes were made in Round 2:

Operating Budget

Introduction of a \$500 Health Care Spending Account - Cut \$9,500 Membership Dues (StreetScan) - Keep \$4,000 Library Agreement - Arnprior (Community/Resource Librarian) - Cut \$14,156 Human Resources - Cut \$850

These additional changes brought the proposed tax levy increase to 8.3%.

RESOLUTION - SM - 11-2020

Moved by Deputy Mayor Brian Armsden, seconded by Councillor Scott Brum **THAT** Council accept the 2020 Operating Budget as information as submitted and circulated.

CARRIED.

7.2 Proposed 2020 Capital Budget

Treasurer Coughlin suggested shifting some items in the proposed Capital Budget around as follows, and Council was in favour:

98-13 Fire Chief Truck - Finance the replacement of the truck (\$59,000) from the Fire Vehicle & Equipment Reserve as opposed to taxation.

97-13 Pumper Tanker - The replacement of this asset is estimated to be \$410,000. The original financing included a provision that \$15,000 be financed from taxation. However, Council voted in favour to add the \$15,000 amount to the debt amount already required to finance this capital acquisition. As a result, this asset will be financed as follows: \$200,000 from the Fire Vehicle & Equipment Reserve, \$45,000 from Lot Development and \$165,000 by debt.

GR#2 Grader - The proposed budget of \$450,000 be financed fully by debt.

This brought the proposed 2020 levy increase to 6.26%.

RESOLUTION - SM - 12-2020

Moved by Councillor Oliver Jacob, seconded by Councillor Scott Brum **THAT** Council accept the proposed 2020 Capital Budget as information as submitted and circulated.

CARRIED.

Staff Direction: Staff was directed to post the Notice of the Intention of Passing of the Budget on February 18, 2020. Council further directed that the January 23, 2020 Special Council Meeting would not be required.
