This ministerial order would designate this property from Highway Commercial E-1 to Industrial Zoning. This ministerial order will allow proposed industrial development to proceed ultimately creating 500 to 600 new jobs in the Township of McNab/Braeside located in the Riding of Renfrew-Nipissing-Pembroke.
