**THEREFORE BE IT RESOLVED** that the Township of McNab/Braeside strongly opposes these utility locate costs being downloaded to Ontario municipalities by Enbridge Gas or other utilities;

**AND FURTHER THAT** the Province of Ontario's Ministry of Public and Business Service Delivery make it clear that these costs must be borne by the utilities themselves:

**AND FURTHER THAT** this decision be forwarded to Minister of Public and Business Service Delivery Kaleed Rasheed, Minister of Infrastructure Kinga Surma, Minister of Energy Todd Smith, Premier Doug Ford, Township of McNab/Braeside's MPP, John Yakabuski, the Association of Ontario Road Supervisors and the Association of Municipalities of Ontario.

**THEREFORE BE IT RESOLVED THAT** the Council of McNab/Braeside Township declares the week of April 9 through 15, 2023, to be National Public Safety Telecommunicators Week in the Township of McNab/Braeside, in honor of the people whose diligence and professionalism keep our Township and citizens safe.

### 15. Public Questions/Comments

15.1 Mike Groulx suggested Council explore the option of purchasing a battery that is designed to work efficiently in colder temperatures (for the Black Cat Speed box).

Mr. Groulx asked for clarification on what recreation programming may not be included for reimbursement if offered by the Township of McNab/Braeside or Town of Renfrew and asked if he could have a list of said excluded items at the next Council Meeting. Mayor MacKenzie advised that once it has been addressed, there will be a list provided.

Mr. Groulx indicated that there was a clause in the original Recreation Agreement that allowed for renegotiation and he stated that since Arnprior is not agreeable to renegotiation if they are now in breach of the Agreement. Mayor MacKenzie said that hasn't been discussed but it will be taken into consideration.

Mr. Groulx asked for clarification on Mayor MacKenzie's statement with that there are numbers that Council are not aware of, he asked why isn't Council aware of them and when will they be available to the public? Mayor MacKenzie clarified that Council may or may not be aware that the numbers are there in raw form, but they aren't grouped together so it's clearly seen what our programming, buildings and other things cost, he indicated that they will be grouped together differently for the next meeting so Council can make an informed decision.

15.2 Adam Cybulski stated that negotiations for the Recreation Agreement could have been done prior to terminating the Agreement. He asked if it was necessary to cancel it in order to get what Council wanted out of the renegotiation. Mayor MacKenzie indicated that Council made a decision based on the information in front of them.

Mr. Cybulski further asked how Council can ensure our residents/ratepayers are going to get into programs offered by the Town of Arnprior as now we don't have the privilege of registering three days in advance of the programming being open to the general public. Deputy Mayor Hoddinott indicated that she doesn't thing the delay in registering is the issue, rather there just aren't enough slots available. She further indicated that the Township intends to develop something to be able to offer aquatic programming at one of our beaches.

Mr. Cybulski asked if the administration costs associated with reimbursing our residents will be included as part of the Recreation budget when the numbers come out so residents know what those additional costs are. Mayor MacKenzie indicated that the information Council's been missing this whole time is how many people are using the Recreation Agreement and the first time those numbers were made available was in the Town of Arnprior staff report a week ago and that specific information has not been provided. Mayor MacKenzie questioned why the Agreement was made for just the Nick Smith Centre as opposed to for all the Recreation across the Region. Mayor MacKenzie will be providing more information to Council. He stated that we've

never charged or even considered charging out of Town rates. Mayor MacKenzie further stated that Council has always taken the best interest of the greater community in mind. He clarified that all he asked the Town of Arnprior to do was remove the indoor programming costs. He apologized for reading the situation incorrectly with the Town of Arnprior and had no idea that they wouldn't be open to renegotiating.

Mr. Cybulski indicated that if we start charging an out of Town fee, we may hurt our own programs as Arnprior may just start their own programs instead of paying the out of Town rates here, which would cause the Township to lose the revenue. Mayor MacKenzie indicated that no one is considering charging an out of Town rate here. Mayor MacKenzie further stated that all costs have to be considered and as an example the deficit on our soccer fields are the same as the deficit at the rink at Nick Smith Centre. He will be preparing a report showing these numbers. He hopes to have another Agreement with the Town of Arnprior that is a two-way Agreement.

Mr. Cybulski stated again that the Agreement should have been negotiated and not terminated.

- 15.3 Brad Shane stated that most of the residents of McNab/Braeside and the Town of Arnprior see themselves as one community, he further stated that there shouldn't be a winner and a loser in this Agreement. He asked why no one has sat in a room and talked about this Agreement. How did it get cancelled when there hasn't been a meeting about it. Mayor MacKenzie indicated that Council's decision was clear and as soon as a decision was made, he sent a letter to Mayor McGee asking for a sit-down and Mayor McGee's reply was no.
- 15.4 Sarah Groulx stated that there seems to be a lot of missing pieces and is wondering when there will be a plan. Deputy Mayor Hoddinott brought up the question to Ms. Groulx that if the Township offers the same program as Arnprior, should that be something the Township reimburses. Deputy Mayor Hoddinott provided clarification that the Agreement is still valid until June 30th and our residents can still register for programs until then under our current Agreement. She further indicated that there are discussions happening to replace everything possible in our Township should there not be an Agreement in place with the Town of Arnprior by 2024. Ms. Groulx indicated that these programs should have been determined and in place before terminating the Agreement.

Ms. Groulx asked again, what's the plan? She asked what the usage numbers are and Mayor MacKenzie indicated he could send the numbers to her.

Ms. Groulx asked if next April there will be questions about what's going to happen that year and what if the numbers are too high? Mayor MacKenzie indicated that we can't act on hypothetical questions. He further stated that the Township is going to find out from the associations their feedback and numbers on McNab/Braeside resident usage. Mayor MacKenzie provided background information on the current Recreation Agreement. Mayor MacKenzie indicated that we need our residents to come and help out staff by contributing to the community.

Ms. Groulx asked where the community involvement was when the decision to terminate the Agreement was made. She stated that the community is being

- left in the dark. Mayor MacKenzie apologized. Mayor MacKenzie also indicated that Council has decided not to engage in social media battles.
- 15.5 Mike Groulx indicated that he doesn't think Council will get accurate numbers from the Town of Arnprior and he hopes Council also gets numbers from the Town of Arnprior with regards to usage.
- 15.6 Brad Shane asked if anyone has reached out to the associations for numbers. Mayor MacKenzie indicated that the association members have been invited to discuss this at the April Public Recreation and Culture Meeting. Deputy Mayor Hoddinott advised that the meeting is open to the public.
  Mr. Shane asked how he can get on the Committee to which Mayor MacKenzie indicated that he can apply on our website. Deputy Mayor Hoddinott suggested live streaming the Public Recreation & Culture committee meeting. Mayor MacKenzie indicated that it would be too short of notice for staff and would require too much staff time but that it could be discussed at the meeting.
