Add to Section 15. Confidential Documentation

"The Clerk shall distribute and collect back all confidential reports and material for closed sessions, including any handwritten notes taken by members of Council during the closed session. If a member determines that he or she has a potential Pecuniary or Conflict of Interest, he or she shall return the materials to the Clerk. The Clerk shall note in the minutes and destroy the documents.

Add to Section 73(3) Committees of Council Establishment/Appointment The Standing Committees may be composed of designated Members of Council, as well as members of the public. The names of members required to serve including the Chair and Vice-Chair if necessary on each Standing Committee may be determined by the Mayor and approved by Council.

Add new Clause to Section 73 Committees of Council Establishment/Appointment as follows:

All public members applications shall be submitted to the Clerk's office for review and appointment by Council.

Change the word "Mayor" to "Council" in the following clauses under Section 73 - Committees of Council Establishment/Appointment

- (1) In the first quarter of Council, immediately after communications, petitions, etc., having been read by the Clerk, the Mayor Council may select and appoint the Standing Committees and Ad Hoc Committees for the current year to the Council.
- (3) The Standing Committees may be composed of designated Members of Council. The names of members required to serve including the Chair and Vice-Chair if necessary on each Standing Committee may be determined by the Mayor and approved by Council.

(5) The names of members to be appointed to any Board, Commission or other body to which Council is required or empowered to appoint persons will be determined by Council.
