15.1 Rod Smith thanked Council for the approval of purchasing the trees from the Kemptville Nursery in order to move the tree planting initiative forward. He provided an explanation on the progress of this project and the purpose of the different kinds of trees to be planted indicating that the White Pines that are being donated by Forest Ontario do not do well in open fields, therefore the purchase of Poplar Trees is required to provide shade and prevent the infestation of White Pine weevil bugs. The Poplar trees will be fast growing and provide the necessary light conditions for the White Pine and White Spruce trees. Although Forest Ontario is donating the majority of the trees the Township needs to contribute \$5,000 to purchase Poplar trees and \$1,000 to pay the tree planters for a total of \$6,000 in order for this project to move forward.
