17.2 V.O.I.C.E. - Council Members Opposed to Strong Mayor Powers

RESOLUTION - 329-2025

Moved by Councillor Kevin Rosien, seconded by Councillor Robert Campbell **WHEREAS** the Government of Ontario has imposed "Strong Mayor Powers" on municipalities without broad consultation or consent;

AND WHEREAS over 120 municipalities have passed resolutions opposing these powers and requested their removal, some as early as 2023;

AND WHEREAS strong mayor powers concentrate authority in one office, undermining democratic governance, council collaboration, and transparency;

AND WHEREAS municipalities are most effective through shared leadership and local decision-making;

THEREFORE BE IT RESOLVED THAT the Township of McNab/Braeside opposes the imposition of strong mayor powers;

AND FURTHER THAT this resolution be sent to the Honourable Doug Ford, Premier of Ontario, the Honourable Rob Flack, Minister of Municipal Affairs and Housing, Billy Denault, MPP, the Association of Municipalities of Ontario, the Association of Municipal Managers, Clerks and Treasurers of Ontario and Councillor Paula Banks, Township of Rideau Lakes.

Moved by Councillor Kevin Rosien, seconded by Councillor Jill Campbell **WHEREAS** Terry Fox was an innovator, attempting to run across Canada on one leg on a humanitarian mission we had never seen before;

AND WHEREAS the Terry Fox Run is inspired by a dream as big as our country, which began in 1980 with Terry Fox and his Marathon of Hope. The run is now entirely volunteer driven, and grounded in traditions with events held annually around the world to foster research in the fight against cancer;

AND WHEREAS it has become a tradition in Canada to gather friends and family to participate in a volunteer fundraiser to raise public awareness and financial support for cancer research;

AND WHEREAS we recognize the importance of cancer research as part of the aims and objectives of the Terry Fox Run on behalf of the people of Canada, of the Province of Ontario, and of the Township of McNab/Braeside;

THEREFORE BE IT RESOLVED THAT Council of the Township of McNab/Braeside, do hereby proclaim the second Sunday in September as "Terry Fox Day" in the Township of McNab/Braeside.

17.6 Suicide Prevention Day Proclamation

RESOLUTION - 333-2025

Moved by Deputy Mayor Scott Brum, seconded by Councillor Robert Campbell **WHEREAS** approximately 4,500 people in Canada die by suicide every year, with suicide being the second leading cause of death among youth and young adults aged 15-34 years;

AND WHEREAS World Suicide Prevention Day is internationally recognized on September 10th to raise awareness about suicide prevention, reduce stigma, and encourage individuals to seek help;

AND WHEREAS by educating, reaching out, and providing support, we can help reduce the number of lives lost to suicide and offer hope and healing to those affected:

AND WHEREAS there are resources available which gives community members the knowledge and skills to identify those at risk of suicide and make life-saving interventions;

AND WHEREAS by recognizing Suicide Prevention Day, we affirm our commitment to building a thriving, healthy, and inclusive community where all residents feel safe, supported, and heard;

THEREFORE BE IT RESOLVED THAT Council of the Corporation of the Township of McNab/Braeside do hereby proclaim September 10 as "Suicide Awareness Day" in the Township of McNab/Braeside;

AND BE IT FURTHER RESOLVED THAT on this day we honour the memory of those who have lost their lives to suicide and extend our heartfelt condolences to their families, friends and share our commitment to prevent future tragedies.
