**AND WHEREAS** Council is further concerned that approval of the application may establish an undesirable intensification on an undersized lot, contrary to the intent of Township and County planning policies;

**NOW THEREFORE BE IT RESOLVED THAT** the Council of the Township of McNab/Braeside does not support the proposed Official Plan Amendment for

160 Usborne Street as submitted, as it is inconsistent with established policies respecting minimum lot size and access;

**BE IT FURTHER RESOLVED THAT** a copy of this resolution be included with the Township's official comments submitted to the County of Renfrew Planning Services Department.
