## **Seasonal Employment, Parks and Recreation Department**

Job Type: Outdoor Rink Attendant / Seasonal

Work Location: John A. Gilles Recreation Centre (JAG), 138 Sarah St. E. Braeside and

White Lake Park, 33 Diamond Lane

Hours: Approx. 27 hours per week, per location

Monday - Friday beginning at 2 pm + Weekends and Holidays - full day

Wage: \$1,000 per week (\$500 per location/ week)

#### Terms:

- The contractor must be able to assume both rink locations for the season.
- Start date and duration to be determined based on weather.
- The season is based on a 10-week period. If weather or equipment conditions do not support this term, the period may be shortened. A possibility to extend the 10-week period is possible if weather conditions are favourable and with Council approval.
- The contractor will be paid on a weekly basis, pro-rated for the start date.
- The contractor will have use of a Township owned snowblower at each location.
- The contractor will have use of a Township owned ice-resurfacer for use at the JAG.
- The contractor will not have access to an ice-resurfacer at White Lake Park.

### Responsibilities:

Reporting to the Recreation Director, the primary responsibilities for the Outdoor Rink Attendant position include (but not limited to) the following:

- Flood and maintain the ice surface.
- Ensure that the ice surface is usable for public skating, rentals and special events.
- Operate an ice-resurfacer on the JAG rink.

- The Rink Attendant is responsible for opening and closing the JAG to accommodate access to the changerooms and washrooms for Public Skating. Mon Fri = close the building at 9 pm (staff will open) + Sat, Sun & holidays = open the building at 9 am and close at 9 pm.
- Assist with light housekeeping duties; stock/tidy washrooms, mop change area, dispose of garbage in public areas including around the rink.
- Shovel the entrance of the building and path to the rink as required during the noted times to ensure that access is clear and safe.
  - o Mon Fri beginning at 2 pm
  - o Sat, Sun + holidays ready for a 9 am opening and as required
- Conduct safety checks on rink and ice making equipment and report any concerns.

# The successful candidate will have the following qualifications:

- Ability to adhere to flexible hours including evenings, weekends, and holidays
- Experience operating a tractor (Case 385)
- Demonstrated ability to work independently
- Excellent safety record
- Exercises care with equipment, rink boards and property
- Ability to meet the physical labour demands of the position
- Possess a Valid driver's license

## As an independent contractor the Rink Attendant is required to provide:

- A Certificate of Commercial General Liability Insurance with a minimum of \$2,000,000 in coverage and naming the township as an additional insured. This coverage must remain in place for the entire term of the contract.
- WSIB coverage
