9.1 McNab Centre Park - New Building & Costs to Complete Re-Design

The major changes that the Committee reviewed and are looking to implement in the redesign are as follows:

- Reduce the overall size of the building by approx. 22% from 1335 sqft to 1035 sqft. (see attached)
- Revise the masonry work (block walls) to a framed construction.
- Revise footing/foundation walls for a floating slab on grade.
- Remove built-in AC unit servicing the tournament room.
- Completing the demolition of the existing structure under a separate contract or internally.
